# **Privacy Policy**

Last revised on July 1, 2024

We understand the importance of your personal privacy. Therefore, we have created this Privacy Policy so that you know how we use and disclose your information when you make it available to us. #### **How We Use Your Information**

We use information that we collect about you or that you provide us, to present the website and its contents to you, to provide you with our services and for the following purposes:

### **Verify Your Identity**

## **Sharing Your Information**

- We may disclose aggregated information about our users, and information that does not identify any individual, without restriction. We further reserve the right to disclose any of your personal information that we believe, in good faith, appropriate or necessary to take precautions against liability, to investigate and defend against any third-party claims or allegations, to assist government enforcement agencies, to protect the security or integrity of the site or our services, or to protect the rights, property, or

- personal safety of https://www.krakenautomations.com, its users, issuers, or others.
- We may also share your information with a buyer or other successor in the event
  of a merger, divestiture, restructuring, reorganization, dissolution, or other sale or
  transfer of some or all of our assets, whether as a going concern or as part of
  bankruptcy, liquidation, or similar proceeding, in which personal information held
  by us about our website users is among the assets transferred. Should this
  situation arise, we will notify you in advance and give you a chance to continue or
  close your account.

#### Cookies

When visiting the website, https://www.krakenautomations.com may collect data collectively known as cookies to ensure a more user-friendly web experience. Only those employees or contracted third parties who need access to your information in order to perform their duties are authorized to have access to your personally identifiable information.
